

### About Alpine Select

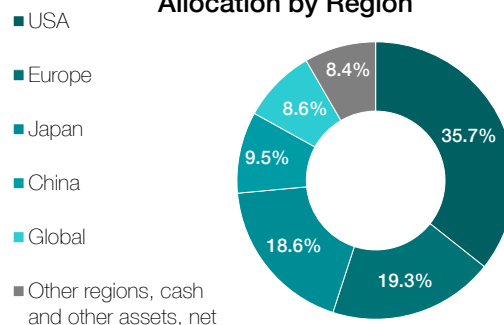
Alpine Select Ltd. is an investment company listed on the SIX Swiss Exchange. The

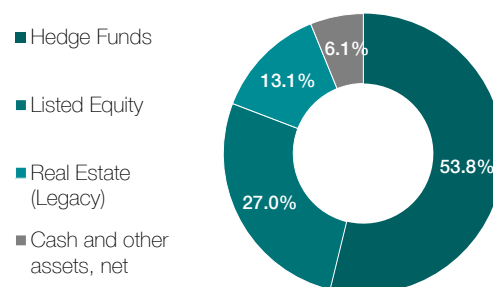
### Allocation by Region

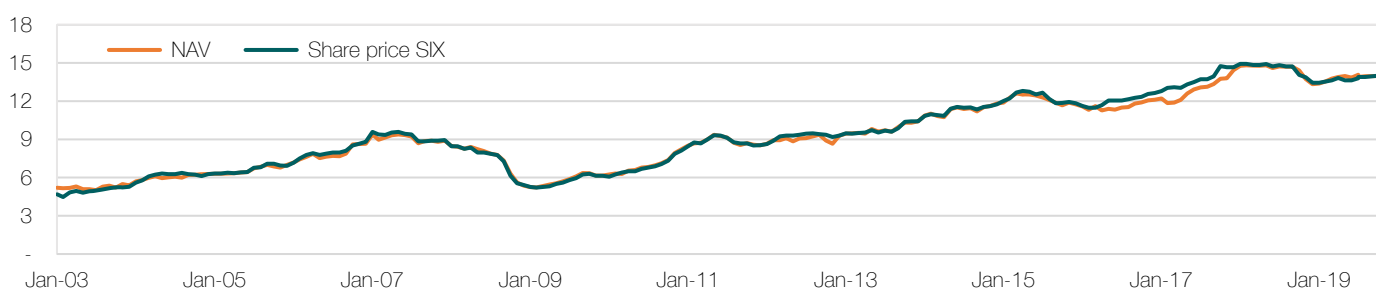
